Sandy Hibbard Creative and Client agree to the following terms:

- Client will provide SHC with login information (account/username and password) for each social media network and blog site/web site to be posted to by SHC under this agreement in order for SHC to perform SVB* program setup services.
- Client grants SHC permission to access and post content to Client's social media networks, blog site*, website, using Client's account(s) login credentials.
- Client will notify SHC of changes to account/username and/or password of any social media, blog/website* if changed by Client. Client will not be reimbursed or given credit for daily posts that are rejected by a social media network due to failure of Client to notify SHC of changes to login information.
- SHC will post themed content on up to three (3) of Client's social media networks each weekday (Monday through Friday) at various times of the day/night.
- Posted content may be created by SHC or procured by SHC from other sources.
- Credit cards are required for month to month payments.
- Checks will be accepted for annual payments only.
- For month to month payments: After the initial payment, monthly payments will be automatically charged to Client's credit card at the first of each month throughout the term of the agreement.
- Client may change their selected themes for future months by notifying SHC in writing 5 business days prior to Client's next billing date.
- Due to the nature of social media and blogging* and since daily social media posts and weekly blog posts* are set up and running in advance, all payments are non-refundable.
- Client may cancel program at any time with a 30 day notice, however no refunds will be issued for monthly fees already processed.
- Only the unused portion of an annual payement (if applicable) will be refunded on cancelation by Client.
- SHC may cancel the program or Client's participation in the program at any time with 30 day notice.
- Any services outside of the ones listed above are not included in this agreement and will contracted and paid for under separate agreement.

SVB Program Setup:

- Utilization of The Social Voice Box [PLUS] program requires Client to establish and/or maintain account(s) on social media network(s) and has an existing blog or website with a blog page*. This agreement assumes that Client has or will establish an account on each social media network to be posted to by SHC under this agreement. This agreement also assumes that Client has an existing blog* or website with a blog ready page that can be posted to by SHC under this agreement.
- Assisting Client with setup of new or alterations to current Client accounts on blog/website, or social media networks, if required, will be performed under separate agreement and for an additional fee that will be agreed upon by both parties.



*If Client chooses the SVB [PLUS] program, SHC will post one themed blog post to Client's blog site each week and syndicate same blog post across all Client's social media networks on file. If Client does not have a blog, post will be made on the LinkedIn Article Page.
